



## Process Technician

The Process Technician will perform the core work of the facility, which includes receiving, aggregating, and processing refrigerant sourced from throughout the United States and delivered to the warehouse.

### Responsibilities:

- Receive, inspect, weigh, and record refrigerant cylinder shipments
- Transfer and aggregate refrigerant from small cylinders and cans to larger cylinders and tanks
- Reclaim refrigerant to meet AHRI standards
- Maintain accurate and detailed records and documentation of daily tasks including shipment receipts, refrigerant sampling and analysis, refrigerant aggregation, etc.
- Monitor process equipment and complete log sheet readings
- Perform routine maintenance and troubleshooting of refrigerant handling and testing equipment
- Operate forklifts safely and efficiently, follow all OSHA safety regulations and perform vehicle safety checks
- Ensure the warehouse stays safe, clean, clutter-free and operating efficiently
- Monitor and control equipment using a computerized control system
- Occasionally assist in the procurement of refrigerant for shipment to the facility

- Previous work history and/or military experience
- Experience in a manufacturing or shop environment
